# RESOLUTION OF BOARD OF TRUSTEES AUTHORIZING VOTE OF NO CONFIDENCE IN MAYOR IAN BANKS

- WHEREAS, Village Treasurer Dorinda Mittiga ("Treasurer Mittiga") was duly appointed to the office of Village Treasurer in April of 2019; and
- WHEREAS, Treasurer Mittiga continued in such position through a statutory two year term ending in April, 2021; and
- WHEREAS, no Village Treasurer was appointed by the Mayor or approved by the Board of Trustees since the end of Treasurer Mittiga's term in 2021; and
- WHEREAS, pursuant to New York State Public Officer's Law § 5, Treasurer Mittiga remains a holdover in her office until such time as a new Treasurer appointment is made by the Mayor and approved by the Board of Trustees; and
- WHEREAS, the Rockland County Department of Personnel ("County Personnel") sent correspondence to the Village on August 9, 2022 confirming that Treasurer Mittiga became a holdover in office as of April, 2021; and
- WHEREAS, County Personnel also reported that the Mayor had signed and filed a document with County Personnel indicating there was no fiscal officer (a/k/a Treasurer) for the Village and that the Mayor marked the space for the Treasurer's name as "N/A"; and
- WHEREAS, County Personnel also reported in its correspondence that commentary was placed on the Village's annual payroll file stating that the Treasurer was not an appointed official and that the Village had filed appropriate termination paperwork concerning Treasurer Mittiga; and
- WHEREAS, County Personnel also reported that on March 1, 2022 the Mayor signed a document declaring himself as the fiscal officer of the Village; and
- WHEREAS, County Personnel also reported that the Mayor also submitted inconsistent statements to their office including a June 9, 2021 payroll certification signed by both the Mayor and Treasurer Mittiga and on July 5, 2022 the Mayor filed a payroll certification checklist, and signed the document indicating that Ms. Mittiga is the Treasurer and fiscal officer of the Village; and



WHEREAS, Dorinda Mittiga is the lawful holder of the office of Village Treasurer and there is no question of law in that regard; and

WHEREAS, due to the Mayor's conflicting and inaccurate statements to County Personnel, the County of Rockland has now commenced a declaratory action in the Rockland County Supreme Court against the Village seeking to have the Court declare the proper legal status of the Village Treasurer; and

WHEREAS, the Village Board desires to adopt this Resolution confirming its vote of no confidence in the Mayor and condemning his baseless actions that will now cost Village residents unnecessary expenses associated with litigation that is entirely wasteful.

## NOW, THEREFORE, BE IT FURTHER RESOLVED that:

- Section 1. The above "WHEREAS" clauses are incorporated herein as if set forth in full.
- Section 2. The members of the Village Board, as indicated in the roll call below, hereby adopt this vote of no confidence in Mayor Ian Banks as Village Mayor in the Village of Pomona.
- Section 3. The Village Board hereby condemns the Mayor's action in causing Village residents to incur unnecessary expenses associated with litigation that arises solely from the Mayor's transmission of completely inaccurate and inconsistent information to the Rockland County Department of Personnel all of which is contrary to well established law confirming the Village Treasurer remains as a holdover in her office and is entitled to all compensation and benefits associated with such position.
- Section 4. The Village Board has determined that the Mayor has no legal support or any valid claim that the Treasurer is not legally holding title to her office, yet the Mayor has refused to concede that his baseless position has no merit and has refused to communicate to the Rockland County Department of Personnel that Dorinda Mittiga remains the Village Treasurer despite the Mayor's personal objection.
- Section 5. The Village Board further determines the Mayor, in engaging in these baseless actions resulting in litigation expenses to the Village residents, is acting outside the scope of his official duties and shall not be entitled to any defense for indemnification from the Village for his actions.
- <u>Section 6</u>. This Resolution shall be effective immediately.
