RESOLUTION APPROVING MS4 ANNUAL REPORT

WHEREAS, pursuant to the existing SPDES permit, the Village is required to develop, implement and enforce a Stormwater management Program ("SWMP") designed to reduce the discharge of contaminants in Stormwater to the maximum extent practical; and

WHEREAS, the Village is required to conduct an annual evaluation of the Village's progress in implementing the program and submit an annual report to New York State Department of Environmental Conservation; and

WHEREAS, a public meeting is required in order to describe the contents of the annual report and public comments must be included in the final version of the report to be submitted to the Department of Environmental Conservation; and

WHEREAS, the draft 2023 MS4 Annual Report was posted on the Village website; and

WHEREAS, a properly noticed public meeting was held on June 26, 2023 to discuss the 2023 annual report at which time all members of the public had the opportunity to be heard.

NOW, THEREFORE, BE IT RESOLVED, that the Village Board of the Village of Pomona hereby approve the 2023 MS4 Annual Report.

Many residents spoke for the HOW and how desperately the need for expansion is. A few residents had concerns regarding lighting coming into their homes. They brought up the idea of a privacy fence. WHEREAS, such Special Permit application shall be subject to the provisions of the Village Code, including the scheduling of a Public Hearing; and

WHEREAS, the Village Board desires to declare itself Lead Agency and set a Public Hearing for the Special Permit application.

Appointment of Village Clerk: Resolution of Mayor to appoint Jenna Antoine to the position of Village Clerk to complete the remainder of a two year term that started April 3, 2023 at 12:00 p.m. and ends on April 7, 2025 at 12:00 p.m. By adoption of this Resolution, the Mayor and the Village Board confirm that the Village Clerk's commencement date in the title of Village Clerk is June 12, 2023.

Gde Arsa Artha presented a report on the Pomona Cultural Center and spoke of upcoming summer and fall concerts. Mr. Arsa Artha requested a sum of \$750: \$400 for the musicians and \$350 for refreshments. Upon vote, the motion was carried by all present.

Garbage disposal: Motion to Set Public Hearing for July 24, 2023 at 7:30 pm regarding the Village board's consideration of an Intermunicipal Agreement with Rockland Green for the Village's collection, removal and disposal of garbage, with the costs of same to be billed by Rockland Green through the Town of Ramapo and/or Town of Haverstraw tax bills, as applicable. Post Notice of Public Hearing in the Journal News in regards to Rockland Green being considered in regards to trash collection, for a five year term to begin on January 1, 2024.

Bid for Burgess Meredith Playground Equipment for \$200,000: Authorizing the Village Engineer in conjunction with the Village Clerk to issue Bids for the purchase and installation of playground equipment at the Burgess Meredith Park with the dates of issuance and the dates of return of such bids to be determined by the Village Engineer and Village Clerk. Upon vote, the motion was carried by all present.

Trustee Marc Greenberg brought up the park signage at Van Den Park, needs to be re-done really cannot read any of the park rules.
