### RESOLUTION AUTHORIZING EXTENSION OF AGREEMENT FOR REFUSE AND RECYCLABLES COLLECTION AND DISPOSAL

WHEREAS, the Village of Pomona ("Village") previously entered into an Agreement with Interstate Waste Services, Inc. ("IWS") for collection and disposal of garbage, trash and recyclables; and

WHEREAS, such Agreement was entered into following advertisement and submission of sealed bids; and

WHEREAS, such Agreement is set to expire on August 31, 2023; and

WHEREAS, the Village desires to extend such services through the end of 2023; and

WHEREAS, the Town of Ramapo had previously bid a substantially similar contract and utilizes IWS for such collection and disposal services; and

WHEREAS, the Agreement with the Town of Ramapo expires on December 31, 2023; and

WHEREAS, the Village seeks to extend the terms of its Agreement on the same terms and conditions as set forth in the Town of Ramapo Agreement with IWS through December 31, 2023.

# NOW, THEREFORE, BE IT FURTHER RESOLVED that:

- <u>Section 1</u>. The above "WHEREAS" clauses are incorporated herein as if set forth in full.
- Section 2. The Village Board hereby authorizes the Mayor, or his designee, to execute any and all documents necessary to extend the Village's collection and disposal services with IWS through December 31, 2023 as the rates presented by IWS in effect in the Town of Ramapo and annexed hereto.
- <u>Section 3</u>. The Mayor and any officer, employee or consultant as directed by the Mayor is hereby authorized to take any and all actions necessary to carry out the provisions of this Resolution.
- Section 4. This Resolution shall be effective immediately.

The following Resolution was duly offered and seconded to wit:

#### RESOLUTION AUTHORIZING USE OF BURGESS MEREDITH PARK

WHEREAS, the Village has received a request from Congregation Ahavas Chesed of 10 Emerald Drive, Pomona, New York ("Applicant") to utilize Burgess Meredith Park ("Park") for recreational activities for underprivileged children; and

WHEREAS, the Applicant has also offered to replace the current basketball backboards and hoops in the Park and to clean up overgrown areas around the courts; and

WHEREAS, the Applicant requests the use of the basketball courts and open field areas for the period of June 28, 2023 through August 17, 2023 from 9:30 a.m. to 4:00 p.m., Monday through Thursday, and 9:30 a.m. to 1:00 p.m. on Fridays, with a final schedule to be provided to the Village which may include some variation as to the stated times.

## NOW, THEREFORE, BE IT FURTHER RESOLVED that:

- Section 1. The above "WHEREAS" clauses are incorporated herein as if set forth in full.
- <u>Section 2</u>. The Village Board hereby approves the use of the basketball court and open field area of Burgess Meredith Park for the non-profit organization, Congregation Ahavas Chesed subject to:
  - 1. Submission of a Facility Use Application in a final form approved by the Village Board;
  - 2. Submission of proof of insurance naming the Village as additional insured;
  - 3. Submission of a final schedule confirming the dates and times of use which shall not include weekends;
  - 4. Submission of proof of the applicant's non-profit status.
  - 5. Submission of \$1,000 to be held in escrow to ensure that the park is ceaned after daily use and restored to its pre-use condition by the end date of the camp program.

<u>Section</u> 3. Upon confirmation of the applicant's non-profit status, the Village Board hereby waives any fees associated with the proposed use of Burgess Meredith Park.

<u>Section 4.</u> Prior to the replacement of any backboards or hoops at the Burgess Meredith Basketball Court, the Applicant will submit specifications with regard to such backboards and hoops prior to installation and same shall be approved by the Mayor.

<u>Section 5</u>. The Mayor and any official, employee or consultant as directed by the Mayor is hereby authorized to take any and all actions necessary to carry out of the provisions of this Resolution.

<u>Section 6</u>. The Board of Trustees retains the right to terminate use of the park at any time in the event that the Applicant fails to comply with the conditions set forth herein.

Section 7. This Resolution shall be effective immediately.
