WHEREAS, the Village Board desires to implement regulations regarding filming within the Village; and

WHEREAS, this action of adopting a local law is a Type II Action under SEQRA; and

WHEREAS, a Public Hearing was held on September 11, 2023 concerning the proposed local law and all interested persons were afforded an opportunity to be heard; and

WHEREAS, the Village Board further desires to establish these related to filming activities in the Village.

NOW, THEREFORE, BE IT FURTHER RESOLVED that:

- Section 1. The above "WHEREAS" clauses are incorporated herein as if set forth in full.
- <u>Section 2</u>. The Village Board hereby adopts the local law entitled "A LOCAL LAW REGULATING FILMING, VIDEO RECORDING AND SIMILAR ACTIVITY" to be enacted as Chapter 69 of the Village Code.
- <u>Section 3.</u> The Mayor, and any officer, employee or consultant of the Village as directed by the Mayor is hereby authorized to take any and all actions necessary to carry out the provisions of this Resolution.

Village of Pomona Filming Fees to be incorporated into Fee Schedule pursuant to Local Law on Filming

- 1. Nonrefundable application fee: \$300; nonrefundable application fee of \$100 for applicants filming for approved educational purposes.
- 2. Daily permit fee schedule:

| Crew Size | Fee for First Day | Fee for Each Additional Day |
|-------------------|-------------------|-----------------------------|
| 1 to 2 people | \$350 | \$0 |
| 3 to 15 people | \$1,000 | \$750 |
| 16 or more people | \$1,500 | \$1,000 |

- 3. Security deposit: \$1,000. In the event that the Village Clerk determines that the conditions of the permit have been violated, the Village Clerk shall be authorized to declare that the security deposit is forfeited in its entirety.
- 4. Reimbursement for DPW and other involved Village employees or agencies: time and a half per hour. Police costs shall be as determined by the police agency providing services.
- 5. Cost for the use of Village buildings or facilities at the rate of \$50 per hour.

RESOLUTION REGARDING HARDSHIP WAIVER OF SECURITY POSTING FOR HOUSE OF WORSHIP

WHEREAS, the Village has received a Special Permit application from Chabad of the Heights ("Congregation") (S/B/L 25.05-2-13) pursuant to the Village's House of Worship Local Law; and

WHEREAS, provisions of the Village Code require the posting of security in connection with site plan approval for such projects; and

WHEREAS, the Village Board desires to consider amendment of the Local Law to amend the Village Code to allow for a hardship waiver for the posting of such security requirements for non-for-profit organizations; and

WHEREAS, the Village has received correspondence from the Congregation requesting a waiver of the security posting requirement due to financial hardship and based on the financing of such Congregation coming from donations; and

WHEREAS, the Village Board desires to consider such hardship requests.

NOW, THEREFORE, BE IT FURTHER RESOLVED that:

- Section 1. The above "WHEREAS" clauses are incorporated herein as if set forth in full.
- <u>Section 2</u>. The Village Board hereby authorizes the waiver of the security posting requirements for the Congregation as identified herein subject to compliance with any and all applicable provisions of the Special Permit, the Village Code and any conditions identified by the Village Engineer, except that such waiver shall not exceed security posting in excess of \$300,000.
- <u>Section 3</u>. The Mayor and any officer, employee or consultant as directed by the Village Mayor is hereby authorized to take any and all actions necessary to carry out the provisions of this Resolution.
- Section 4. This Resolution shall be effective immediately.
