WHEREAS, the Village previously issued a Special Permit application from Chabad of the Heights ("Congregation") (S/B/L 25.05-2-13) pursuant to the Village's House of Worship Local Law; and

WHEREAS, provisions of the Village Code require the posting of security in connection with site plan approval for such projects to insure site restoration; and

WHEREAS, the Congregation had previously posted \$75,000 in security in lieu of a Letter of Credit concerning such property and special permit; and

WHEREAS, the Congregation building was damaged by fire and subsequently demolished due to said fire and the Congregation has since substantially restored the property to its pre-construction condition; and

WHEREAS, the Board desires to now return the \$75,000 previously posted by the Congregation along with any interest accrued during such time that the money was on deposit with the Village.

NOW, THEREFORE, BE IT FURTHER RESOLVED that:

Section 1. The above "WHEREAS" clauses are incorporated herein as if set forth in full.

Section 2.
