WHEREAS, the County of Rockland has offered the Village of Pomona a grant through the American Rescue Plan Act of 2021 (ARPA) to fund a Walking path at the Burgess Meredith Park in the Village; and

WHEREAS, the Village of Pomona wishes to accept this grant and utilize the funds to make improvements to the park for the benefit of the community; and

WHEREAS, the Mayor of the Village of Pomona has the authority to enter into agreements on behalf of the Village; and

NOW, THEREFORE, BE IT RESOLVED THAT:

Section 1. The above "WHEREAS" clauses are incorporated herein as if set forth in full.

Section 2. The Mayor is hereby authorized to execute an Agreement between the County of Rockland and the Village of Pomona for the receipt of ARPA grant funds for a Walking path at the Burgess Meredith Park in the Village.

Section 3. The Mayor or Deputy Mayor, and any officer, employee or consultant, as directed by the Mayor, is hereby authorized to take any and all actions necessary to carry out the provisions of this resolution.

Section 4. This Resolution shall be effective immediately.
